Electric Vehicle (EV) Time-of-Use (TOU) Charging Agreement

"Cooperative") and		(hereinafter refer	rred to a	s the "Member").
The named parties understand and agree to the	ne followin	a:		

- 1. The Member understands that EV charging TOU "Rate Schedule 167EV, 168EV, 169EV" is a separately metered, optional rate and agrees to the rate and terms as outlined in the rate schedule and approved by the Board of Directors. Services already on the "Optional Residential TOU' rate schedule may also be approved to connect a level-two hardwired EV charger.
- 2. It is recommended that the Member's EV charger is a hard-wired, level-two charger.
- 3. The Member understands they may choose to move to another available and appropriate rate at any time only after being enrolled in this rate schedule for a minimum period of 12 months.
- 4. The Cooperative shall not be liable for any damage or economic loss due to power interruption, such as an outage.
- 5. Member will assume ownership of the existing secondary wire if owned by the Cooperative at the time of entering this agreement. The member or member's electrician shall verify that the existing secondary wire is sized accordingly and make upgrades if necessary.
- 6. Services with interconnected distributed generation do not qualify to have a sub-metered TOU service. The TOU service would have to be parallel metered.
- 7. Member must submit pictures of their clearly labeled electrical panel and any equipment connected to the charger's panel prior to receiving the EV Charging TOU rate.
- 8. The Cooperative reserves the right to modify the terms and conditions of all rate schedules from time to time.
- 9. This Agreement shall be in effect as of the date indicated, for the period in which the current Member is occupying this location and chooses to be enrolled in this TOU rate. When service under this TOU rate is terminated, the member will be moved to an appropriate non-TOU rate and the Member shall not be eligible to apply for this rate for a period of 12 months.
- 10. This Agreement shall be binding upon and inure to the benefit of the successors, legal representatives and assigns of the respective parties.
